

Briana's Law

Brianna's Law went into effect 1 January 2020 and will be fully implemented on 1 January 2025. The law requires that every operator of "mechanically propelled" boats successfully complete an approved boater safety course by 2025. It depends on when you were born to determine if you need the certification starting in 2020.

Here's the schedule of when certification is required: In 2020 if you were born after 1 January 1993: In 2022 if you were born after 1January 1988: In 2023 you were born before 1January 1983: In 2024 if you were born before 1 January, 1975: Finally, in 2025 EVERYONE will need it.

The USPS Safe Boating Course (ABC) meets the requirements and is an approved course. (By SEO Les Smith, JN)

Jump Start Program....A Two Hour on-the-Water Training Program

The Jump Start Program has been developed as a tool to help increase recreational boating safety. The Jump Start Program is a hands-on training program from the Boat Operator Certification Committee of the United States Power Squadrons. It provides a framework for teaching a one-on-one training session with a student on their own boat. The content of the training is customized to fit the needs of the individual student. The goal is to help the new boat owner develop essential skills for safe operation of their boat, and to break through any barriers that may limit their boating enjoyment. The Jump Start Program provides a personalized, high-quality training experience for the student. It also helps the student bond with the squadron, and encourages participation in additional squadron training and activities.

The target time for the training is set at two hours. This provides a reasonable amount of time to teach a number of skills. It also sets reasonable expectations for the student. Some additional preparation time will be required by the instructor. Of course, an instructor can always spend more time working with a student if they choose to do so. But we recommended completing the initial training session before considering additional one-on-one training.

This program is intended for boaters who need some basic hands-on training in order to operate their boat safely and with confidence. The student can be a members or non-member. For non-members, consider using this program as a recruiting tool. The student should be the owner of a new boat, or at least a boat new to them. The boat may be of any type or size, as long as the instructor has relevant experience. The student's boat may be kept in a marina, or may be on a trailer. Launching and retrieving the boat may be part of the training. The student should have some boating experience, but has limited experience with a boat of this type. The Jump Start program is not intended as a substitute for other USPS training and courses.

Recommended prerequisites for the Jump Start Program are:

A current certificate indicating that the student has successfully completed a boating safety course.

The student has some actual experience as a boat operator.

The student must be the owner of the boat or designated in writing, by the owner, as the principle operator.

The trainer is limited to teaching boat operation and safety and not advanced topics as taught in our advanced courses, except where safety issues are involved. Basic operation of boat systems can be included in the Jump Start program.
